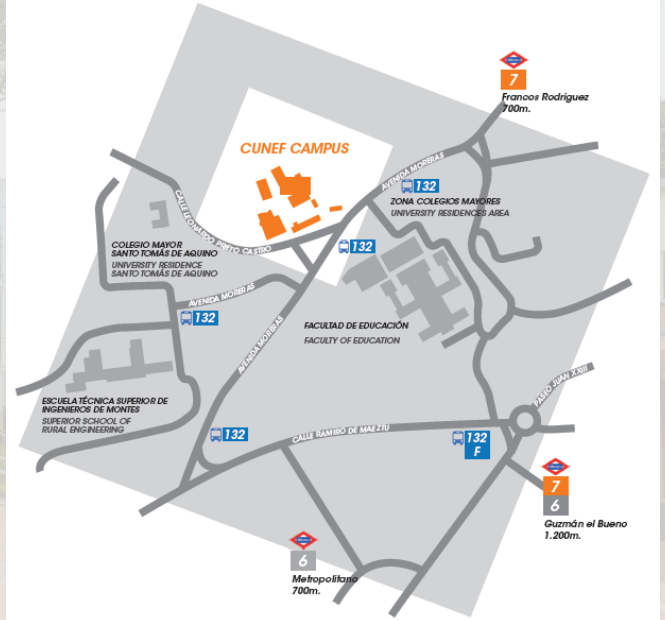

BACHELOR DEGREE in Business Administration

The Bachelor Degree in Business Administration is designed to train professionals to perform management, advisory and evaluation work in all kinds of corporations.

This work is performed in a global environment, as well as in any of its functional areas: production, human resources, finance, sales and marketing, investment, administration or accounting, among others.

DOUBLE DEGREE in Laws & Business Administration

FINANCE SUMMER SCHOOL

The **CUNEF Summer School** offers intensive, specialist courses allowing participants to complete or refresh their training in specific areas of finance.

They adopt a practical, hands-on approach to the different subjects on the program. They are designed for graduates, practicing professionals or university students on their last year. They include extra curricular activities (panel discussions, guest speakers, institutional or business visits, cultural and fun activities, etc.) with the aim of maximizing the training experience both professionally and personally.

Computer Services
